Discussion and Updates in P4F Early Childhood Iowa Area

- **a.** Duhrkopf provided an update on the Association of Early Childhood Iowa Area Boards and Advocates Annual Meeting she attended on November 14. The two areas that the Association will advocate for in the next legislative session is A. Increased Funding and B. Maintaing the local control of ECI to ensure an avenue for quick action.
- b. The FY24 Annual Report of Family Support programs from DAISEY, I2D2 and the ECI Office was presented. Duhrkopf and Sara Skinner shared how the change in entering the ASQ was not a smooth transition and data is skewed because of it. Duhrkopf noted that the programs were always doing the ASQ which is of importance when serving the children. The data points were discussed. Nunn bought up the fact that sometimes with such small number of families/children the data may appear negative but in fact is a positive. DAISEY is the state mandated data reporting system that is good but has limitations.
- c. Duhrkopf and Skinner provided the board scenarios that the state may implement or the P4F Board would want to implement if a nationally accredited family support program is need in order to receive funding from ECI. Duhrkopf and Skinner researched two programs that are most widely used in Iowa PAT-Parents as Teachers and HFA-Healthy Families America. The information will continue to be updated for future reference.
