Thirty Million Words-Building a Child's Brain By Dana Suskind MD was the focus of our follow up discussion at the March 21st ECTF meeting. Early Childhood providers discussed how they had implemented the 3 T's in to their work. The 3 T's are Tune In, Talk More, Take Turns. These three strategies are important whether working with children, parents or co-workers.

Persons attending appreciated the training that took place in the fall and spring. It allowed for implementation and feedback.

In FY19 P4F will return to the local county meetings twice a year most likely in October and March or April. Plan to attend and collaborate with the other early childhood providers in the area.
