Early Childhood Task Force meetings: Planning an October 20th ACES Training

Early Childhood Formula: Base 5%, 0-5 Pop 35%, 185% of FPL 0-5 6 FY22 is the last year of the phase in. Our allocation in FY22 of \$86,078 should now be pretty stable moving forward. It has allowed P4F to fund the Child Care Advisor and the Child Care Nurse Consultant.

Social Media/Facebook: Continue to promote items every Tuesday or more often

Preschools: FY21 only 20 children were served. Down from 37 the year before but Carroll Area Child Care Center and Preschool may be back in the fall.

H.O.P.E.S.: They are following their agency's guidelines on conducting visits. Carroll County HOPES will have their virtual re-credentialing visit October 5th and 6th, P4F Board members will be asked to participate in a small portion of the visit-virtually. Greene and Guthrie will both be scheduled for the fall as well.

Child Care: Additional funding from state available for expansion. Currently working with the community of Guthrie Center on efforts to expand childcare in their community.

Child Care Task Force recommendations are being released. Unfortunately, some suggestions are to lessen the restrictions on registration of home providers. This is moving Iowa backwards in regards to oversight of the environments where children are.

Area Director: Wrapping up FY21 and working on the annual report that is due September 15th and starting FY22.

P4F Board PD: Family support will be the focus of the entire year for P4F.
