Early Childhood Formula: Phase in over 4 years (Base 5%, 0-5 Pop 35%, 185% of FPL 0-5 6-%) Will begin in FY19, FY21 is 3rd year.

Preschools: Less than 22 three year olds enrolled. Only 4 preschools participating. Visited with Zion in Manning regarding next year and change in teacher.

H.O.P.E.S.: Conducting visits virtually either by phone or Zoom. State is recommending this continue until further notice

Child Care:

Child care centers are juggling with staff contacting COVID-19 and classrooms having to quarantine. Very few children are contacting the virus at centers.

Delivered mask and other items to child care registered homes in all four counties in conjunction with Beth Walters at CCR&R
