Starting in November, we will be making available a handout and activity to families in our four county area. We will distribute over 1000 copies through childcare sites, libraries, WIC and other programs. The P4F Board meets 8-10 times a year on the third Thursday of the month at 11:00 AM. Members


are asked to serve a three-year term.
